- 1 Certificate of income of the person planning to move in, a document to prove the relationship to the resident (family register abstract resident register etc.), and other documents deemed as necessary by the governor (or, in cases where the property is managed by Shizuoka Housing Supply Corporation or the city/town, the Administrative Director of the Shizuoka Prefectural Housing Supply Corporation or the mayor of the city/town.)
- When the application is approved by the governor (and not by the Administrative Director of the Shizuoka Prefectural Housing Supply Corporation or the mayor of the city/town in cases where the property is managed by the Shizuoka Housing Supply Corporation or the city/town), you do not need to submit an Appeal Against the Certified Income as specified in the provisions of Article 7 of the Shizuoka Prefecture Prefectural Housing Ordinance Enforcement Regulations.
- 3 To confirm that the person planning to move in is not a member of an organized crime syndicate, we may crosscheck with the chief of the police department.
